1. 2015 Ocean Way Holiday Report

Kris Mory, CRA Director, stated that the Ocean Way Holiday event was not well attended due to the weather; however, it was well attended throughout the entire month. Further, Ms. Mory said the event was on budget and there are plans to hold the event in the future.

2. CRA Resolution No. 2016/005 - A Resolution of the City of Deerfield Beach Community Redevelopment Agency (CRA) authorizing a budget transfer in the amount of \$8,500 from the CRA's Infrastructure and Capital Improvements budget to Regular Salary budget.*

The Resolution was read by title.

GENERAL ITEMS - CONTINUED

Chair Robb opened the public hearing; there was none to speak and the public hearing was closed.

3. Presentation by Walters Zackria Associates regarding North Beach Pavilion redevelopment.

Kris Mory, CRA Director, stated that in October 2015, the Board approved a scope of services for Walters Zackria Associates to prepare a conceptual design for the redevelopment of the North Beach Pavilion. When the scope of services was approved, an entry level redevelopment of the existing facility was discussed; whereby, it was suggested to have something more midstream with an activity center that would fulfill beach and recreational needs. Thereafter, Ms. Mory introduced Abbas Zackria.

Abbas Zackria, Walters Zackria Associates, displayed a presentation of the proposed redevelopment of the North Beach Pavilion. He explained that three (3) options are being provided, per the contract. Thereafter, Mr. Zackria continued displaying the options.

In response to Chair Robb's question, Mr. Zackria replied that no parking spaces will be lost, as it will be the same footprint as the existing building.

Vice Chair Ganz arrived at 6:39 p.m.

In response to Chair Robb's question, Ms. Mory replied that this year's budget includes funding for professional services to design this project. She explained that \$600,000 of money this year has been set aside for infrastructure and capital improvements which will be rolled over to next fiscal year and added to the new tax increment revenue to fully fund construction for FY 2017. Further, Ms. Mory stated that next year there will be \$1.9 million for infrastructure and capital improvements. Lastly, she stated that the firm will be paid from this year's budget.

Motion was made by Mr. Miller and seconded by Mr. Rosenzweig to move forward with option C (see attached). Voice Vote:



ADJOURNMENT




