A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA; APPROVING AMENDMENTS TO THE 2012 AND 2013 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ACTION PLANS

WHEREAS, the proposed use of funds and how the project/activities will help achieve the overall goal and objectives are outlined in the City of Deerfield Beach’s 2010-2014 Consolidated Plan; and

WHEREAS, the proposed amendments will principally benefit lower income residents of the City of Deerfield Beach; and

WHEREAS, the City has advertised the amendments that will impact previously approved Action Plans; and

WHEREAS, the Community Development Division recommends that the Commission approve the Amendments;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DEERFIELD BEACH, FLORIDA, AS FOLLOWS:

Section 1. The above referenced “Whereas” clauses are true and correct and made a part hereof.

Section 2. The City Commission hereby approves the Amendments to the 2012 and 2013 CDBG Action Plans and authorizes the City Manager or designee to take all necessary actions to implement the Amendments.

Section 3. This resolution shall become effective upon passage.

We are requesting your approval for the Community Development Division to increase the line item for the Community Development Block Grant (CDBG) in order to expend funds for the CDBG planning & administration, home rehabilitation/repair, capital and infrastructure activities and projects.

Attached is documentation from the Housing & Urban Development (HUD)'s IDIS database indicating funding availability for administration and planning from 2010, 2011, & 2012 of \$249,183.05 that needs to be included in the City's Budget for 2013-2014 under account #106-8000-554-32-99:
